	PART – I: PRELIMINARY
1.	Short title and commencement:
(i)	These regulations may be called the MAFSU Academic Regulations forBachelor of Fisheries Science(B.F.Sc.)Degree Course (2024): 'The Maharashtra Animal & Fishery Sciences University Academic Regulations for the award of Bachelor of Fisheries Science(B.F.Sc.)Degree Course (2024)'. (EC/ xxxx /2024)
(ii)	These Regulations shall be in accordance with the recommendations of the ICAR Sixth Deans' Committee Report, Agricultural Education Division, ICAR, New Delhi, Dtd. 10.09.2024
(iii)	They shall come in force from the academic year, $2024 - 2025$ and shall be applicable to all the students getting admission from the year $2024 - 25$ and onwards.
2.	<b>Definitions:</b> In these regulations unless the context otherwise requires:
(a)	<b>Academic Bank of Credits (ABC)</b> means a digital data base that manages information relating to the credits earned by students to accumulate, verify, transfer and redeem their credits.
(b)	<b>'College/Institute'</b> means the constituent college(s) established/may be established under university with the objective to impart Fisheries Scienceeducation.
(c)	<b>'Competent Authority'</b> means the Authority of the Maharashtra Animal and Fishery Sciences University, Nagpur and/or its constituent Colleges/ Centers. Depending upon the context, it may include the Vice-Chancellor, the Dean(s), Associate Dean(s), the Head(s) of the Institute, the Registrar, the Deputy Registrar(s), the Controller of Examinations, Director of Student Welfare, the Hostel Warden(s) and/or Head(s) of the Teaching Departments of the University and/or such other authority connected with the affairs of the University as may be designated by the Vice-Chancellor to be such Competent Authority.
(d)	'Contact Hours' means the total clock hours of each per week per semester
	for theory and practicals in respect of a course.
(e)	<b>'Course</b> ' means a course is a unit of instruction or segment of subject matter as specified in the course curriculum to be covered in a semester. It has a specified code number, title and credits, which may be determined by the appropriate authority of the University.

	PART - II: COURSE OF STUDY
3.	Degree Course
3.1	The undergraduate program of Bachelor of Fisheries Science (B. F. Sc.) is of <b>182 credit hours comprising 172 credit hours of coursework and 10 credit</b> <b>hours of online courses (MOOCs/SWAYAM etc.)</b> . Additionally, the program also comprises of 4 credit hours of two non-gradial courses (Deeksharambh: 2
3.2	<ul> <li>credits and Study tour: 2 credits).</li> <li>a) A degree course of Bachelor of Fisheries Science (B. F. Sc.) shall comprise of a course of study consisting of curriculum and syllabus specified in ICAR Sixth Deans' Committee Report spread over four years (eight semesters) including Core Courses, Basic Supporting Courses (BSC) [Multi-Disciplinary courses (MDC), Value Added Course (VAC), Ability Enhancement Courses (AEC)], Skill Enhancement Courses (SEC), Elective Courses and Student READY program as prescribed in the syllabus.</li> </ul>
	b) After admission of students in the university, the students will register for non-gradial courses such as two weeks of <i>Deeksharambh</i> in the I semester and Educational tour of 15 days in V semester
3.3	The first year of the course is dedicated to knowledge and skill enhancement, including applied aspects of Fisheries. After satisfactory completion of two semesters and subsequent satisfactory completion of 10 credits (10 weeks) of internship/ industry/ institute/ farm attachment, the student will become eligible for the award of <b>UG-Certificatein Fisheries Science</b> on exit. Students continuing their studies further would not have to attend the internship after the I year.
3.4	The second year has been designed with practical exposure on Fisheries as well as skill enhancement courses and some part of fundamental courses related to fisheries with adequate theory and practical components, enabling the student to get acquainted with the basic principles and applications of fisheries. After satisfactory completion of four semesters and subsequent satisfactory completion of 10 credits (10 weeks) of internship/ industry/ institute/ farm attachment, the student will become eligible for the award of <b>UG-Diploma in Fisheries Science</b> on exit. The students continuing the study further, would not have to attend the internship after II year.
3.5	The student will have to register for 06 skill enhancement courses (0 + 12 credits), out of which 02 courses each will be offered in I & II semesters and 01 course each in III & IV semesters. Students can choose the skill enhancement courses offered by the university as per local needs. Thus, the name(s) of modules completed by the student will be reflected in the UG certificate/UG diploma/B.F.Sc. transcript.
3.6	The third and fourth years of the course are designed to impart in-depth details, including specialized knowledge to students in the major disciplines. During the V semester, the students will have a study tour of 10-14 days' duration, which will be counted as 2 credits (non-gradial).
3.7	In the final year (VII Semester), students will have adequate choice of electives/specialized courses (20 credits). The objective is to enable the student to acquire a deeper understanding of any field. However such courses shall be offered considering the significance of regional demands and needs.

3.8	In the VIII Semester, students opting for the 4-year B. F. Sc. degree will undergo 20 credits of the Student READY (Rural Entrepreneurship Awareness
	Development Yojana) program.
3.9	<ul> <li>a) In addition to the prescribed courses, students will have the freedom to opt for 10 credits of non-credit compulsory courses from MOOCs/SWAYAM or any other online portal to groom their passion and add to their knowledge components based on their choice. However, the university will keep a record of such courses registered and completed by each student and will indicate the title of the (successfully completed) courses in the final transcript issued to the student.</li> <li>b) The student shall complete the MOOCs/SWAYAM or any other online courses preferably before VII Semester of the B.F.Sc. degree</li> <li>c) The fees for registering the MOOCs/SWAYAM or any other online portal</li> </ul>
2.10	shall be borne by the students.
3.10	On successfully completing the four years degree requirement, the student will be awarded undergraduate degree <b>Bachelor of Fisheries Science (B. F. Sc.)</b>
3.11	A student admitted to the Bachelor of Fisheries Science (B. F. Sc.) Degree programme in the University should complete the degree programme within a maximum time limit of seven (07) academic years from the date of first registration i.e. within a period of 14 semesters, failing which he/she shall have to discontinue his/her studies and the admission of the student shall stand cancelled.
3.12	The candidates having UG- Certificate in Fisheries or UG- Diploma in Fisheries Sciencewill be allowed admission to the B.F.Sc. (Fisheries Science) program in III or V semester respectively subject to provisions mentioned in regulations 14.1 & 14.2.

7.	REGISTRATION:
7.1	Registration for the First Semester after Admission:
(a)	A student admitted by the University shall become an enrolled student of the university only when he/she reports for his/her registration on the due date mentioned in the admission letter.
(b)	Admission is incomplete without registration of required courses relevant toDegree programme. Hence, all students admitted to the Degree programme should go through the process of Registration in person on the notified date.
7.2	Registration for fifth and Subsequent Semesters:
(a)	Registration for the fifthand higher semesters requires that the student has successfully completed the semester as below:

(i)	A student who fails in a course as specified in Regulations 20.8,19.27 (a) & (b) and21.7,after having fulfilled the attendance criteria for that course, shall be required to register for repeat Internal Midterm Examination(s) and the Semester-End Examination(s) in that course, when the course is next offered.
(h)	The total number of courses that can be registered in any semester shall be limited to a maximum of 24 credits excluding the credits of Internship of II & IV semester.However, the Head of the Institute may permit on recommendation of the Counselor a credit load not exceeding 27 credits as a special case.
(g)	Before a student registers for any number of courses in a semester, he/she shall have to first register for all such courses of the previous semester of the corresponding term, that were either not registered in the relevant semester or are to be repeated for any reason, includingshortage of attendance. He/she shall have to necessarily attend the classes of all such courses, and undertake all examinations and the criteria for attendance etc. as for regular courses shall be applicable.
(f)	Students shall clear all the previous dues of the Hostel(s), Bus transport charges, and Library etc. before registration.
(e)	Attendance shall be counted from the date of commencement of the classes of the semester.
(d)	The date of registration shall be notified in the Academic Calendar.
(c)	Eligible students enrolled in the University and desirous of registration must report to the Head of the Institute and register for the courses running in that semester on the scheduled date notified by the Competent Authority(s) and pay the prescribed fee for the semester. The student shall produce the Identity Card at the time of registration.
(b)	A student who fails to clear the courses for the semester specified in the Regulation 7.2.(a), but who applies for verification of marks of such courses may be provisionally registered after payment of required fees, to the relevant semester pending declaration of the result of verification of marks. Provisional registration of such student will stand cancelled after the declaration of the result of verification of marks, if he/she still fails to clear the courses.
